



EXCEED LEARNING PARTNERSHIP CRITICAL WORKER & VULNERABLE CHILD CRITERIA

The leadership of Exceed have agreed this criterion to give extra clarity and consistency around the critical worker list.

The Government's definition of a 'critical worker' and a 'vulnerable child' is extensive and unless we prioritise, we may not be able to support the vulnerable children, families and workers that require this help the most. We have used the Government's official guidance as well as the Government's official list of critical workers to put critical workers into a priority system from 1 to 4.

Our first priority is children considered vulnerable at any level. After that, those families where one parent (or single parents) are critical workers who cannot work from home. We have prioritised academy staff* within priority 1 in the knowledge that many staff members are local to the area – this should mean that by utilising places for academy staff within our own Trust, we will be able to support many more local families with this childcare arrangement. Although this is an agreed tiered system, we will make a final decision based on our overall staffing capacity but we are hoping provide provision for all pupils on this list.

Current government guidance regarding eligibility for an academy place is that children with at least one parent or carer who are identified as critical workers by the government can **potentially** send their children to school if required. **However, we must emphasise that the government guidance also states that “many parents working in these critical sectors may be able to ensure their child is kept at home. Every child who can be safely cared for at home should be.”**
